Figure 1. The effect of the concentration of the *Agrobacterium* suspension on the transformation efficiency of *Agrobacterium* strains. The *Agrobacterium* strains were grown in the medium containing 100 mg/l of tetracycline. The cells were harvested at the stationary phase of growth and adjusted to the concentration of  $1 \times 10^8$  cells/ml. The cells were then diluted to the concentrations of  $1 \times 10^7$ ,  $1 \times 10^6$ ,  $1 \times 10^5$ ,  $1 \times 10^4$ , and  $1 \times 10^3$  cells/ml. The cells were then mixed with the plant protoplasts and cocultured for 48 h. The transformation efficiency was determined by the number of transformants per protoplast. The results are shown as the mean  $\pm$  SD of three independent experiments.
