For the reasons set forth in the Application the proposed financing transaction does not involve significant hazards considerations as defined in 10 CFR 50.92 and has no environmental significance.

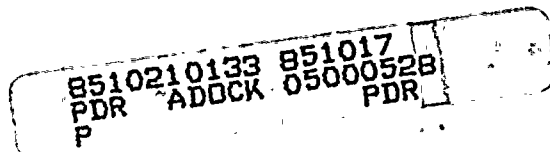
A check in the amount of \$150 is also submitted in payment of the fee for processing this Application.
