

In response to the subject notice of violation, as discussed in the referenced letter, ANPP committed to develop a program to validate and verify (V&V) all RMS software currently in use at Palo Verde Nuclear Generating Station (PVNGS). This program was considered a long range objective and was scheduled for completion during the fourth quarter of 1987. Due to the large number of subordinate tasks required to effectively complete the implementation of this program the expected completion date has been modified to June 15, 1988.

A task plan and detailed discussion of the subordinate tasks have been developed and are available onsite for your review.
