Victoria,

I reviewed the financial instruments that were sent, and there are documents missing in addition to the Certification of Financial Assurance (NUREG 1757, Vol 3, App A.2.4) that I mentioned in an earlier email. The additional documents are:

- Schedule B of the Standby Trust Agreement (STA). Although Schedule B is shown on the same page as Schedule A, it is not completed.
- Schedule C of the STA; this also is on the same page as Schedule A but is not completed.
- Letter of Acknowledgement: this is shown on the same page as the "Specimen Certificate of Resolution". This should be a separate document, completed, and is needed to support the STA. I am trying to find out if the notarization on the STA would be acceptable in lieu of the Letter of Acknowledgement but have not yet gotten an answer to that question. [The Specimen Certificates of Resolution, and of Events, correctly are not required to be filled in at this time.]
