Appendix 9.5A Fire Protection Program

Florida Power & Light Company (FPL) has completed a partial update of the St. Lucie Unit I Final Safety Analysis Report (FSAR) in accordance with 10 CFR 50.71(e) and Generic Letter 86-10. The required ten copies of the updated report are enclosed.

This amendment revises Section 9.5.1 and adds Appendix 9.5A. Appendix 9.5A describes the St. Lucie Unit I Fire Protection Program which includes the fire protection modifications completed prior to August 31, 1986. Fire protection modifications completed between September 1, 1986 and January 22, 1987 will be included in the July 1987 annual update of the FSAR.

All other Plant Change/Modifications (PCM) completed, pursuant to 10 CFR 50.59, between January 23, 1986 and January 22, 1987, which were not part of the Fire Protection Program, will be incorporated in the July 1987 annual update.

All the Fire Protection PCMs incorporated in this amendment were reported to the Commission with the previous FSAR updates.
