This refers to your application request to renew your license dated August 1, 2017. In order to continue our review of your request, the following additional information is needed:

1. Please verify in writing which storage location address is correct, the address listed on your current license (Road 459 KM 15.1, Bo. Bejucos, Isabela, Puerto Rico) or the address listed on your renewal application (Road 459 KM 15.3, Bajuras Ward, Isabela, Puerto Rico).
2. In your renewal application dated August 1, 2017, you referred, on numerous occasions in your application, to Portable Gauge Licenses, NUREG 1556 Vol 1, dated November 2001. Please review the current NUREG-1556 Volume 1, Revision 2, Program-Specific Guidance About Portable Gauge Licenses, June 2016 for updates/changes and update your renewal application to reflect the updated version of the Regulatory Guide. 3. Please verify in writing that the total number, make and model of portable gauges that you are allowed to possess under your current license is still the same number that you would like to possess under your renewed license.
4. Please provide a facility diagram for your permanent portable gauge storage location. Include on the diagram the use of adjacent areas, including above and below.

The letter may be scanned and submitted as a pdf document attached to an email; or it may be transmitted by facsimile to (610) 337-5269; or it may be sent by regular mail. If we do not receive a reply from you within 30 calendar days from the date of this e-mail, we will assume that you do not wish to pursue your application request.
