

Dear Mr. Denton:

In our letter, Reference No 1, Indiana & Michigan Electric Company requested relief from 10 CFR 50.55a(g) to start the second ten year inspection interval on the same date for both Units of the Donald C. Cook Nuclear Plant. In a letter dated October 23, 1984, Ms. Reba M. Diggs of your staff notified us that a sum of \$4400.00 is applicable to the above request for relief.
