CONDUIT SEALING PROGRAM CLARIFICATION

Dear Mr. Denton:

This letter responds to your September 24, 1986 letter requesting clarification of our commitment to seal conduit and the schedule for completion.

In our letter AEP:NRC:0692AG, dated September 13, 1985 we committed to a walkdown of conduits to identify and to add one (1) seal to conduits which penetrate a fire barrier and which are open at both ends. The walkdown portion of the commitment was completed on or about May 30, 1986. Our proposed schedule for completion of the conduit sealing (one (1) end of conduit open at both ends identified during the walkdown) is July 31, 1987.

This walkdown and sealing program is not dependent upon the utility sponsored test program or test program schedule. The July 1987 schedule for D. C. Cook to complete conduit sealing does not relate to the possible need to seal both ends of conduits. We have not considered or committed to sealing both ends of conduits. Our July 1987 proposed schedule for completion of sealing one (1) end of conduit open at both ends identified during the walkdown is based on a reasonable estimate of the work involved. This sealing workload must also interface with other proposed modifications scheduled for the D. C. Cook plant in the next nine months. We will inform you when this sealing program is completed.
