SUBJECT: SUMMARY OF THE NOVEMBER 7, 2017, TELEPHONE
CONFERENCE TO DISCUSS REQUEST FOR EXEMPTION
RELATED TO REPORTING REQUIREMENTS, HONEYWELL
METROPOLIS WORKS (COST ACTIVITY CODE 000224/04003392/
L-2017-LLE-0010)

On November 7, 2017, the U.S. Nuclear Regulatory Commission (NRC) staff held a telephone conference with Honeywell Inc. (Honeywell) to discuss its September 7, 2017, license amendment request regarding an exemption, in part, from the regulatory requirements in Title 10 of the *Code of Federal Regulations* (10 CFR) Section 40.60, Reporting Requirements, regarding its Metropolis Works facility (Agencywide Documents Access and Management System Accession Number ML17255A243). In particular, the NRC staff discussed with Honeywell the proposed license condition provided in their license amendment request. More specifically, Honeywell requested an exemption from the 24-hour reporting requirements in 10 CFR 40.60(b)(3), for an event that requires unplanned medical treatment of an individual with spreadable radioactive contamination on the individual's clothing or body.

As a result of the discussion, Honeywell stated that it would provide a supplement to the aforementioned license amendment request by revising its proposed license condition with a clearer description. No NRC staff decision was made during the telephone conference.
