This letter is intended to inform your staff that the qualification of the ice baskets to carry design loads in the Donald C. Cook Nuclear Plant Units 1 and 2 is supported by Westinghouse Electric Corporation topical reports WCAP-8304 (proprietary) and WCAP-8110 Supplement 8 (non-proprietary) as revised and supplemented by Supplement 1 to WCAP-8304 dated June 27, 1978 and additional information dated October 18, 1978. The safety evaluation of WCAP-8304 as contained in Mr. John F. Stolz' letter dated December 22, 1978 to Mr. Thomas M. Anderson of the Westinghouse Electric Corporation, indicates that topical report WCAP-8304, amended as described above, is acceptable for reference in the license application for the Donald C. Cook Nuclear Plant Units 1 and 2. We hope that this information allows this matter to be closed out on our docket.
