Dear Mr. Denton:

As requested by your staff on March 14, 1984, this letter provides additional information with regard to the daily fire inspection program which was addressed in our letter AEP:NRC:0692L, dated March 8, 1984. Specifically, a procedure is being written which will set forth the following:

1. The effective date that inspections are to begin and the conditions upon which the inspections will be discontinued.
2. The organization and/or the individual(s) responsible for fulfilling the procedural requirements.
3. The areas which will be subjected to the inspection program.
4. The criteria that will be used to identify adverse conditions.
5. The measures to be used to control and to effect corrective actions to adverse conditions (including the individuals who will be notified).
6. The documentation requirements for the inspections.
7. The criteria for determining when exceptions may be taken to the procedure. Exceptions would be granted for such conditions as fully manned areas or areas which have not been entered since the last inspection.
8. The information necessary to verify the availability of fire fighting apparatus and the condition of the apparatus.


Even though the procedure will not become effective until after it is approved, we plan to commence the inspections as soon as sufficient inspection criteria are developed and personnel are trained.
