Dear Mr. Davis:

This letter is being sent to inform you that we are submitting, under separate cover, the exercise scenario for the November 10, 1992, Donald C. Cook Nuclear Plant Emergency Preparedness Exercise to Mr. J. W. McCormick-Barger, Emergency Preparedness Section. This action is being taken in accordance with your March 16, 1987, letter and I.E. Information Notice 85-55: "Revised Emergency Exercise Frequency Rule."

As stated in our August 10, 1992, letter to you, the November 10, 1992, exercise will be a utility only exercise. The State of Michigan will participate in a supportive role but not for the purpose of evaluation. It is intended to conduct the exercise using the Unit 2 simulator and the simulated Technical Support Center in the Cook Nuclear Training Center.

The attachment comprises the complete exercise scenario package with all controller information and simulation data, including plant data, radiation level data, and release rate data. The information is presented here for NRC review and will serve as a back-up in the event of simulator equipment problems.
