Dear Ms. Ullrich,

Thank you for your swift response to our application for a license amendment. I read the amended license (Amendment No. 30) and all the conditions seem clear as stated. I have a comment on the addresses given in Items 10 A & B of the amendment and a question regarding a condition stated in amendment # 29 that is not on amendment # 30.

Really glad to know that you read it. It is most helpful if these kinds of items get caught immediately.

Items 10 A & B. Both the Robert C. Byrd Biotechnology Science Center (BBSC) and the Science building are on the Campus of Marshall University. The address "1705 Third Avenue" specifically refers to the physical location of the Science Building. The address of the BBSC (1700 Third Avenue) is correct but the last 4 digits of the zip code (2505) are too specific. 2505 is the designation for the Radiation Safety Office which is located in the BBSC.

I can issue a Corrected Copy to take care of the zip code for the 1700 3rd avenue address. This was already in our database, so I thought it was correct.

The previous amendment (#29) of our license stated: *The licensee is authorized to transport licensed material in accordance with the provisions of 10 CFR Part 71, "Packaging and Transportation of Radioactive Material."* This statement is not on the

new amendment (#30). Does it need to be on the license or is it covered by item 21 A?

Other changes occurred along with the new format of the license. One change was that we list specific addresses wherever possible. Other change occurred because all of our license conditions were reviewed again by our legal office, and the current lawyers determined that the condition you specified above is not necessary, because the paragraph across the top of the license binds you to Part 71, so they don't believe a specific license condition is necessary. There were some changes to other license conditions as well.

I hope this is clear. I am working from home today and having trouble with my NRC phone, but will be in tomorrow if it is easier to discuss these by telephone.
