Nordion (Canada) Inc. ("Nordion") provides this courtesy notification of corporate and rebranding changes to Nordion's indirect parents that occurred on November 7, 2017. Nordion, a Canadian company headquartered in Ottawa, Ontario, is a leading global provider of gamma technologies and medical isotopes. The Canadian Nuclear Safety Commission regulates Nordion's licensed radioactive materials activities in Canada. For its distribution of licensed materials and manufactured sealed sources in the U.S., Nordion holds NRC License Nos. 54-28275-02MD and 54-28275-01.

Prior to November 7, Nordion was an indirect, wholly-owned subsidiary of Sterigenics-Nordion Holdings, LLC. As part of a corporate consolidation, several indirect parents situated between Nordion and Sterigenics-Nordion Holdings, LLC in the corporate structure were merged. Specifically, Sterigenics Holdings LLC; STHI Holding, LLC; STHI Intermediate Holding, LLC; and STHI Topco Holdings, LLC were simultaneously merged with and into Sterigenics-Nordion Holdings, LLC, and subsequently no longer exist. Pre- and post-consolidation corporate structure diagrams are provided in Attachment 1.

In addition, again on November 7, Sterigenics-Nordion Topco, LLC—the direct parent of Sterigenics-Nordion Holdings, LLC—was converted from a Delaware limited liability company to a Delaware corporation. That conversion was performed by operation of Delaware state law.

Finally, the names of certain surviving entities—Sterigenics-Nordion Topco Parent, L.P.; Sterigenics-Nordion Topco, LLC; Sterigenics-Nordion Holdings, LLC; Sterigenics International LLC; as well as the General Partner (“GP”) of Sterigenics-Nordion Topco Parent, L.P.—have been changed to implement a rebranding effort, to Sotera Health. The below chart, and Attachment 1, reflect these name changes.

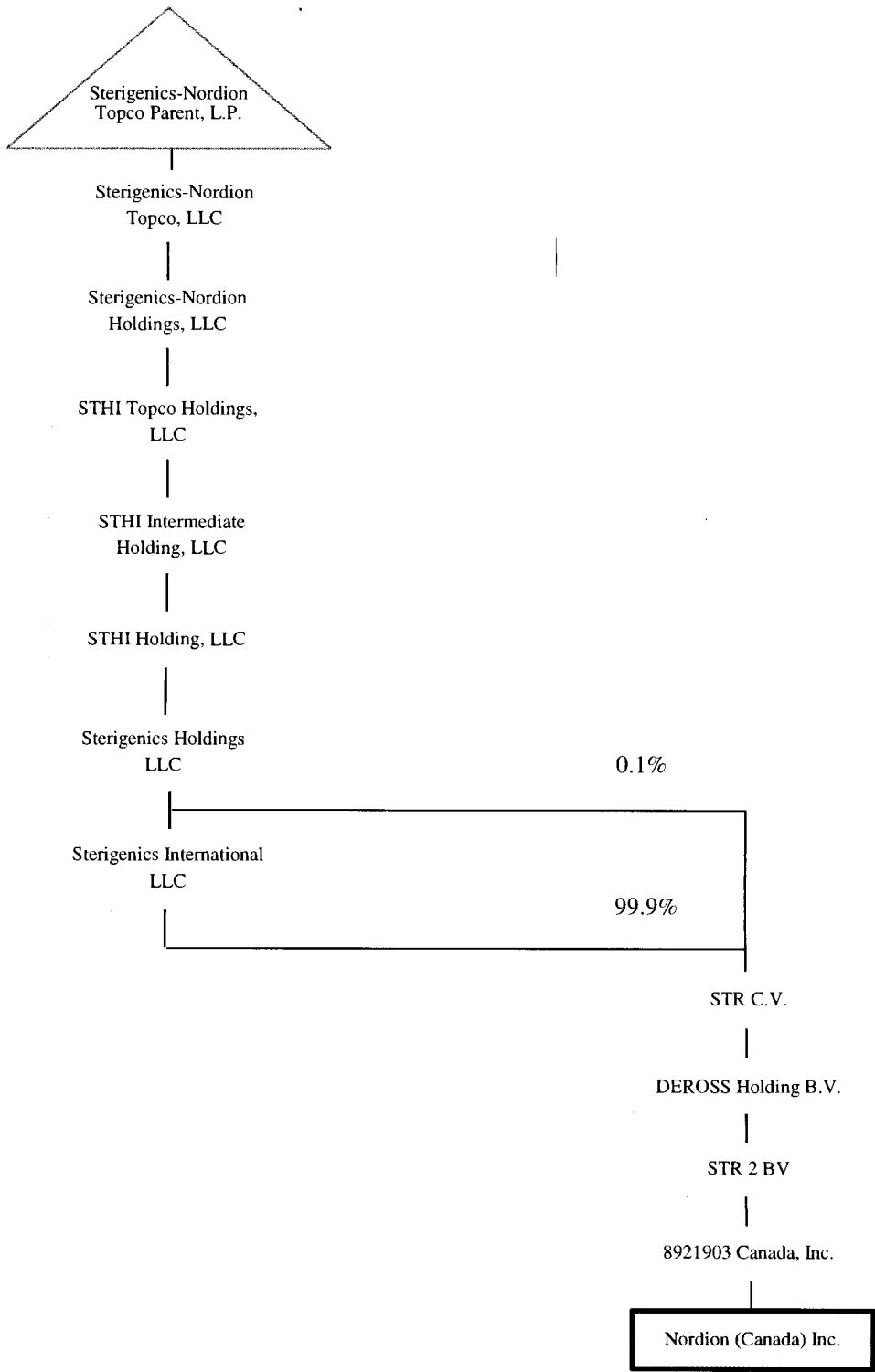

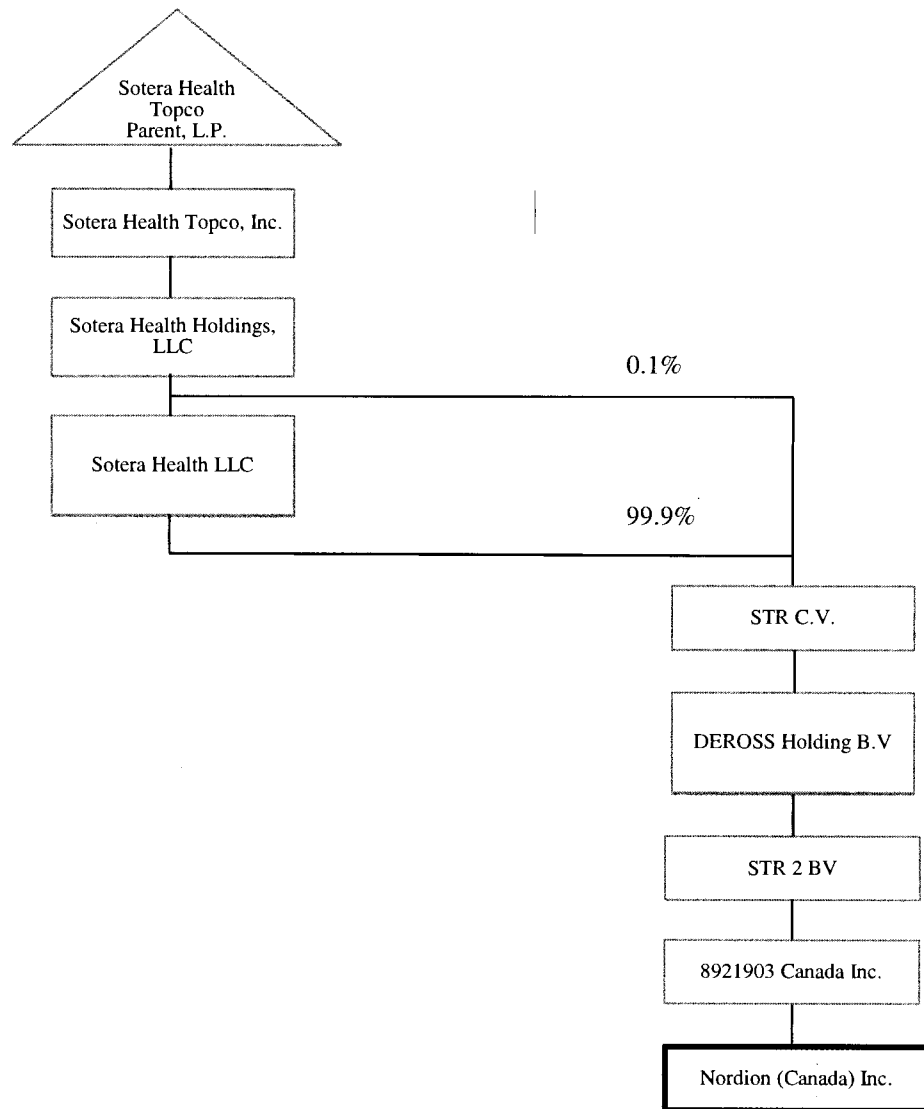
