SUBJECT: RENEWAL OF INITIAL CERTIFICATE AND AMENDMENT NOS. 1 THROUGH 11 AND 13, REVISION 1, AND AMENDMENT NO. 14 OF CERTIFICATE OF COMPLIANCE NO. 1004 FOR THE STANDARDIZED NUHOMS® HORIZONTAL MODULAR STORAGE SYSTEM

Dear Mr. Bondre:

As requested by your application dated October 4, 2014 (as supplemented on October 16, 2015 and June 6, 2016 and September 29, 2016), enclosed are the renewed initial certificate and renewed Amendment Nos. 1 through 11, and 13, Revision 1 and Amendment 14 of Certificate of Compliance (CoC) No. 1004 for the Standardized NUHOMS® Horizontal Modular Storage System. The certificates have been renewed for an additional 40-year term that expires on January 23, 2055, in accordance with the provisions of Part 72.240 of Title 10 of the *Code of Federal Regulations* (10 CFR 72.240). The renewal of these certificates constitutes the U.S. Nuclear Regulatory Commission's (NRC) approval for continued use of the Standardized NUHOMS® Horizontal Modular Storage System for storage of spent nuclear fuel under the general licensing provisions of 10 CFR 72.210, subject to the conditions in the renewed certificate. These conditions require the implementation of an approved aging management program (AMP) to ensure that structures, systems, and components important to safety will continue to perform their intended functions during the extended storage period authorized by the renewal.

As stated in the Federal Register (82 FR 44879, September 27, 2017), the effective date of this CoC is December 11, 2017. The NRC staff's final safety evaluation report for the renewal of the certificates, and Appendix A, "Technical Specifications," for each renewed certificate are also enclosed.
