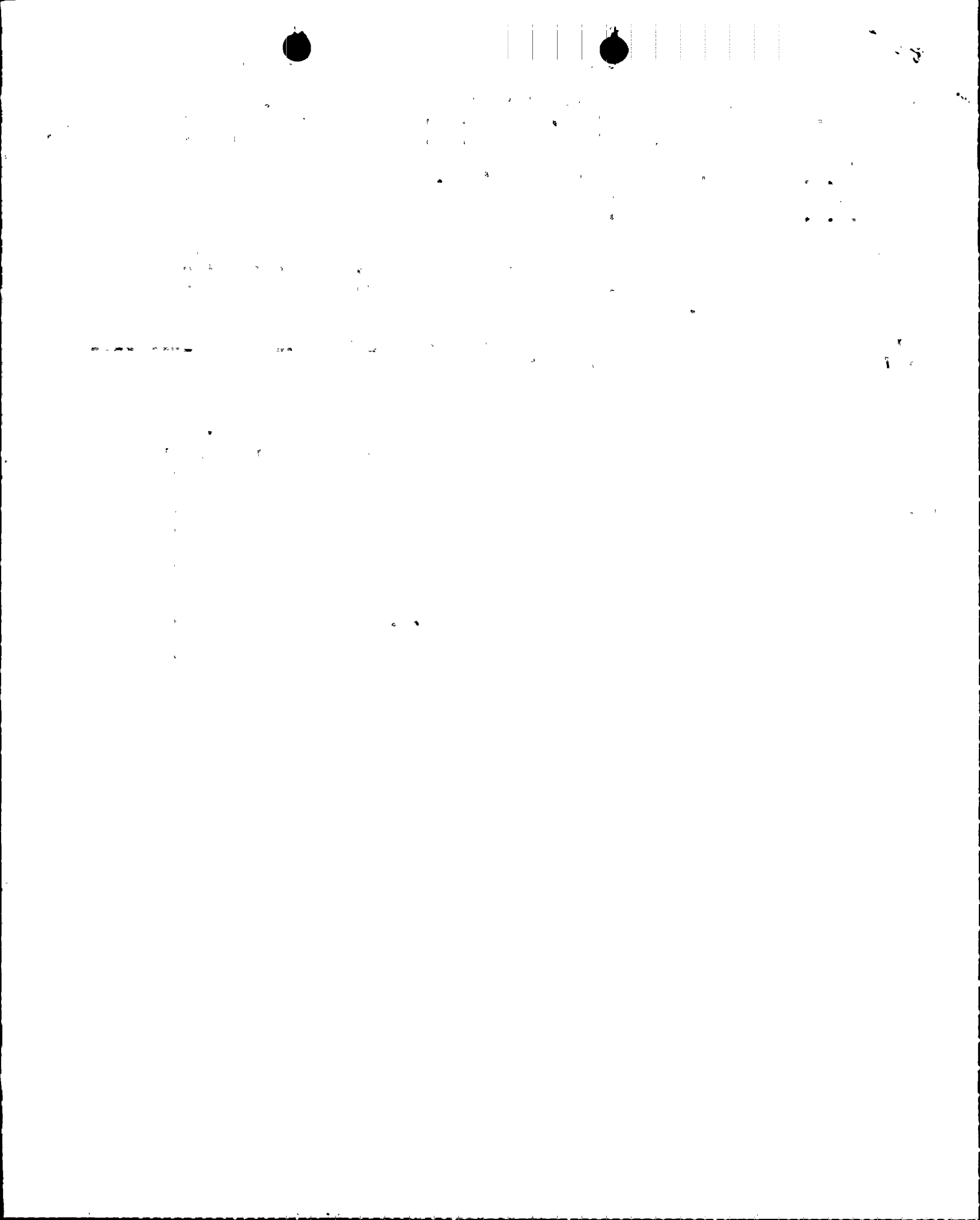

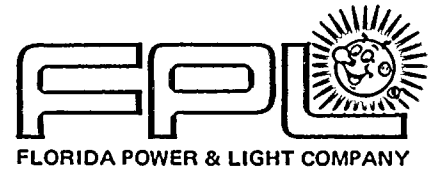

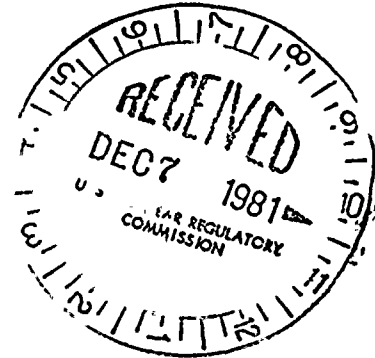

Adequacy of Station Electrical Distribution Voltages

Florida Power & Light has reviewed the NRC letter dated October 22, 1981 which requested additional information on the adequacy of station electrical distribution system voltage for Turkey Point Units 3 & 4. Because of the heavier than normal engineering workload associated with the outages of our three nuclear units, we will not be able to supply the information by the requested date.
