Enclosed is Amendment No. 40 to your Nuclear Regulatory Commission (NRC) Materials License No. 21-11457-02 in accordance with your request.

Also enclosed are Amendment Nos. 8 and 3 for your NRC Materials License Nos. 21-32468-01 and 21-32643-01, respectively, terminating each of these licenses.

As requested in letter dated September 8, 2017, we have added three locations of use. The locations of use were listed on the terminated NRC licenses noted above. The licensees were held by Michigan Cardiology and 2050 Leasing Company and have been terminated concurrently with the issuance of the aforementioned Amendment No. 40.

Please note that your license format has changed in accordance with our new licensing process system. License Condition No. 13 has been deleted in accordance with current Nuclear Regulatory Commission (NRC) policy to include the reference to Title 10 of the Code of Federal Regulations (CFR), Part 71, "Packaging and Transportation of Radioactive Material," in the preamble, on page 1 of the license.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. NRC, Region III office at (630) 829-9887 so that we may provide appropriate corrections and answers.

The NRC's Safety Culture Policy Statement became effective in June 2011. the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

NRC's Regulatory Issue Summary (RIS) 2005-31 provides criteria to identify security-related sensitive information and guidance for handling and marking of such documents. This ensures that potentially sensitive information is not made publicly available through ADAMS, the NRC's electronic document system. Pursuant to NRC's RIS 2005-31 and in accordance with Title 10 of the *Code of Federal Regulations* (CFR) Section 2.390, the enclosed license document is exempt from public disclosure because its disclosure to unauthorized individuals could present a security vulnerability.
