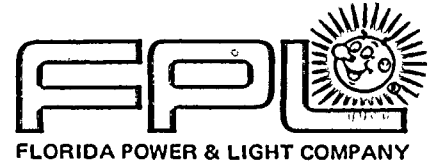

Florida Power & Light Company has actively participated in the NUTAC on NRC Generic Letter 83-28, Item 2.2.2 concerning a Vendor Equipment Technical Information Program (VETIP). It is expected that the NUTAC Report will be published before the end of March 1984.
