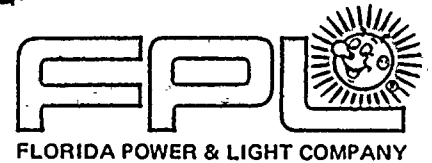

Re: Turkey Point Units 3 and 4  
Docket Nos. 50-250 and 50-251  
Proposed Amendment to Spent  
Fuel Storage Facility Expansion

Florida Power & Light Company has requested approval of expansion of our spent fuel storage facility in L-84-71, dated March 14, 1984. That amendment request was made in order to modify the existing Turkey Point Units 3 and 4 spent fuel storage facilities to accommodate an expected increase in the inventory of spent fuel assemblies above the capacity of the existing storage facilities.

To ensure that the proper technical specification pages are issued, we have updated the pages in our March 14, 1984 submittal (which was subsequently clarified by FPL letter L-84-206 dated August 14, 1984) to reflect those changes made in subsequent license amendments. Those are License Amendments Nos. 103 and 97 issued April 23, 1984 (as corrected by Mr. D. G. McDonald's letter of August 30, 1984) and License Amendments Nos. 109 and 103 issued September 5, 1984 to Facility Operating License Nos. DPR-31 (Turkey Point Unit 3) and DPR-41 (Turkey Point Unit 4).

None of these changes in any way change our initial request nor the supplemental information being evaluated by the NRC staff in support of our request. Also, the changes are merely intended to clarify FPL's continuing intention to retain existing limitations for  $K_{eff}$  for spent fuel which would now be clearly spelled out in the technical specifications.


