SUBJECT: RESPONSE TO NRC INSPECTION REPORT 030-28641/2017-004 AND NOTICE
OF VIOLATION

Dear Lt. Col. Nemmers:

On November 9, 2017, the U.S. Nuclear Regulatory Commission (NRC) cited the Department of the Air Force for a violation involving security-related requirements. Inspection Report 030-28641/2017-004 with enclosed Notice of Violation required you to respond in writing within 30 days. You responded by Memorandum dated December 8, 2017.

After reviewing the information you provided in your response to the Notice of Violation, we have concluded that your completed and proposed corrective actions appear to adequately address the regulatory noncompliance as described in the Notice of Violation. Based on the security-related nature of the violation these details are non-publicly available. We will review your implementation of these corrective actions during a future inspection to determine whether full compliance has been restored and whether compliance will be maintained.

In accordance with 10 CFR 2.390 of the NRC's "Agency Rules of Practice and Procedure," a copy of this letter will be made available electronically for public inspection in the NRC Public Document Room or from the NRC's Agencywide Documents Access Management System (ADAMS), accessible from the NRC Web site at <http://www.nrc.gov/reading-rm/adams.html>.
