DESIGN BASIS RECONSTITUTION

Work continues on a risk based assessment of historic Plant Changes/Modifications.

Reconstitution of design bases for Area Radiation Monitoring, Process Radiation Monitoring and Normal Containment Coolers is proceeding in accordance with the Integrated Schedule.

Verification activities for the original fifteen systems have been initiated.

OTHER SIGNIFICANT PROGRESS

- o Installed identification tags on various DC busses.
- o Developed plan to meet full capacity discharge testing (per IEEE 450) of the station batteries.
- o Installed hydrometer holders in battery rooms.
