This concerns your request for an amended license dated September 8, 2017. Because your Radiation Safety Officer informed us that you are not currently able to provide the additional information required to complete the requested action, we have voided your request. Specifically, to support the addition of Dr. Kemmerer to your license, we require documentation of his completion of: (i) 3 years of residency training in an ACGME accredited Radiation Oncology training program; and (ii) vendor training on the use of the type of device possessed by Bayhealth. This action is taken without prejudice to the resubmission of your request.
