## SELECT SYSTEM REVIEW

### DECEMBER 1988 PROGRESS

#### Design Basis Reconstitution

Design Basis Verification activities for the original fifteen select systems continues in accordance with the Integrated Schedule. Completion of this activity is scheduled for May 8, 1989.

Design Basis Verification activities for Area Radiation Monitoring System (ARMS), Process Radiation Monitoring System (PRMS) and normal containment cooling systems will proceed in accordance with the Integrated Schedule. Completion of this activity is scheduled for June 1, 1989.

#### Walkdowns

Small Bore Piping and Tubing (ARMS, PRMS and normal containment cooling systems)

- ° Unit 4 inside Containment complete including functionality reviews.
- ° Unit 3, 4 and Common area outside Containment in progress in accordance with the Integrated Schedule for completion by February 28, 1989.
- ° Unit 3 inside Containment complete including functionality reviews.

P & ID (ARMS, PRMS and normal containment cooling systems)

- ° Unit 3 inside Containment will be performed during the next Unit 3 refueling outage in accordance with the Integrated Schedule.
