We have reshuffled our suggested audit schedule for the hydrology items. We are planning surface water discussions to begin as soon as all of the permitting discussions have completed on Tuesday (we estimate 10AM) and then the plan is to move to groundwater topics as soon as surface water discussions have concluded. That may or may not occur before the lunch break. At 1:00 on Tuesday, Joe Giacinto will call in and the safety/environmental crossover issues will be discussed. It is my understanding that covers the three carry over items from the safety review. Upon completion of those discussions, the hydrologists will complete all remaining hydrology discussions. This means the alternative system discussion will need to move to Thursday afternoon. The plan is to cover this along with the alternative sites hydro item as soon as the alternative sites folks have completed their discussion of the ecology alternative sites items. We feel this moves the lower priority discussions to occur later in the week.
