
Please find the complete Information Needed for Transfer of Control as required. This transfer is effective January 1, 2018.

1. Community Health Center of Branch County ("CHC") will enter into an agreement with ProMedica Health System, Inc. ("ProMedica"), pursuant to which ProMedica will become the sole corporate member of CHC, with an anticipated effective date of January 1, 2018. 2. There is no change in personnel.
3. There is no change in the location, facilities, equipment, or procedures related to the current NRC license.
4. Our surveillance program is in compliance with NRC regulations and requirements. All programs will remain the same at the time control is transferred.
5. There is no change in the location, facilities, or equipment related to the transfer of control, therefore no decommissioning of the facility will be performed.
6. Promedica Coldwater Regional Hospital will abide by all constraints, conditions, requirements and commitments of the licensed program.



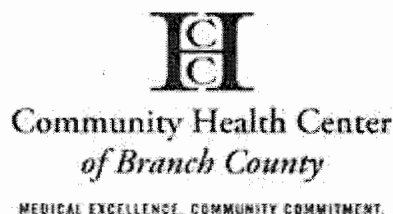
