SUBJECT: SUMMARY OF OCTOBER 5, 2016, CLOSED CONFERENCE CALL WITH THE
PRESSURIZED WATER REACTOR OWNERS GROUP REGARDING
FLUENCE BENCHMARK FOR SUBSEQUENT LICENSE RENEWAL

On October 5, 2016, a closed conference call was held between the U.S. Nuclear Regulatory Commission (NRC) staff and the Pressurized Water Reactor Owners Group (PWROG). During the conference call, the PWROG informed the NRC staff of its proactive plan to generate benchmark dosimetry measurements in the extended beltline which will provide additional data to enable increased certainty in extended beltline fluence calculations in preparation for subsequent license renewal. The NRC staff provided feedback to the PWROG on what was discussed.
