Cancellation of Interim Technical Specifications
Implementation Procedure (0-ADM-021)

As stated in FPL letter L-88-94, dated February 26, 1988, Interim Technical Specifications Implementation Procedure (0-ADM-021) was issued internally by FPL to familiarize the site personnel with the changes in format and the surveillance requirements in the proposed Revised Technical Specifications.

On August 28, 1990, the NRC approved Turkey Point's Revised Technical Specifications. To facilitate the transition from the current Technical Specifications to the Revised Technical Specifications, the Interim Technical Specifications Implementation Procedure (0-ADM-021) has been cancelled, effective October 1, 1990. The cancellation of 0-ADM-021 is necessary to permit the replacement of the Interim Technical Specifications Implementation Procedure (0-ADM-021) with the Revised Technical Specifications. This change is required to ensure the upgrade of all procedures to the Revised Technical Specifications.
