By letter L-91-184, dated June 25, 1991, Florida Power and Light Company (FPL) submitted the Final Report of the results of the Turkey Point IPE for Severe Accident Vulnerabilities. This submittal was discussed by FPL and the Nuclear Regulatory Commission (NRC) at a meeting in Rockville, Maryland on August 27, 1991. By letter dated December 27, 1991, the NRC requested additional information to continue the ongoing review of the Final Report. The NRC's December 27, 1991 letter stated that FPL should either provide the requested information within 30 days, or provide a schedule for the provision of this information. As discussed with Mr. Raj Auluck, NRC Project Manager, Turkey Point, FPL will be providing the requested information by March 12, 1992.
