Implementation Date for the Revision to the EPA Manual
of Protective Action Guides and Protective Actions
for Nuclear Incidents

The purpose of this letter is to advise the NRC that Florida Power and Light (FPL), in consultation with the State of Florida and Florida Power Corporation, will delay implementation of the guidance provided by the Environmental Protection Agency in EPA 400-R-92-001, "Manual of Protective Action Guides and Protective Actions for Nuclear Incidents," until March 31, 1994.

NRC Information Notice 92-38 dated May 12, 1992, notified addressees of a Commission decision which affected the implementation date for the revised manual. It was noted in the Information Notice that the NRC agreed with EPA's recommendation to implement the manual revision concurrently with the revised 10 CFR Part 20. To be consistent with the change in the date for implementing 10 CFR Part 20, the Notice allowed for an implementation delay of the guidance to January 1, 1994.

FPL has conducted meetings with the State of Florida and Florida Power Corporation (FPC) to obtain a coordinated implementation of the EPA guidance. The logic for protective actions has been agreed upon and the methodology for implementation is in its final stages. The only remaining issue is the fact that FPL has an Emergency Response Plan exercise scheduled for February 9, 1994, at the St. Lucie plant. In addition, an exercise is scheduled for January 20, 1994, at FPC's Crystal River plant. In its letter dated October 27, 1993, FPC's Crystal River Plant notified the Commission of its intent to delay implementation of the guidance prior to the end of the first quarter of 1994. FPL, FPC and the State of Florida agree that implementation of the guidance during preparation for these exercises is not prudent. In keeping with the goal of ensuring a coordinated implementation of the new guidance, FPL intends to delay implementation until March 31, 1994, such that State-wide implementation is achieved in a consistent manner.
