This letter is in regards to the renewal of your Registration Certificate No. 727899, issued on May 9, 2017. The purpose of this letter is to inform you of the termination of Animal Diagnostic Laboratory, Inc. General License No. 727899, authorizing the use of by product material for *in vitro* testing in accordance with Title 10 of the *Code of Federal Regulations* (10 CFR) 31.11, "General license for use of byproduct material for certain *in vitro* clinical or laboratory testing." The U.S. Nuclear Regulatory Commission (NRC) is terminating your general license because the address of use of the licensed material is not under NRC jurisdiction. You should contact the State of California and comply with their regulations.
