On November 30, 2017, the U.S. Nuclear Regulatory Commission (NRC) completed a security inspection at the H.B. Robinson Steam Electric Plant, Unit 2. NRC inspectors discussed results of this inspection with Mr. Ernest Kapopoulos, Site Vice President, H.B. Robinson Steam Electric Plant, Unit 2, and other members of your staff. The results of this inspection are documented in the enclosed inspection report.

The NRC inspectors did not identify any findings or violations of more than minor significance.
