**EVALUATION**

By letter dated November 8, 2017, TN Americas LLC requested a renewal to Certificate of Compliance No. 9319, for the Model Nos. MAP-12 and MAP-13 transportation packages. In support of the renewal, the applicant submitted a consolidated application with the following changes to the safety analysis report (SAR):

- Changed name from AREVA NP to TN Americas LLC:
- Added the Proprietary Information Notice page: *A proprietary information notice page was not previously included in the SAR.*
- Revised the Revision Log to reflect Revision 8 changes to the SAR.
- Added a listing of MAP PWR fuel shipping package drawings to Chapter 1, Section 1.3.1: *The listing was not previously included.*

These changes do not affect the ability of the packages to meet the requirements of Title 10 of the *Code of Federal Regulations* Part 71.

**CONDITIONS**

The following changes have been made to the certificate of compliance:

Section 3.a. of the certificate of compliance has been revised to reflect the new name of the certificate holder, as requested.

Condition No. 9 now allows use of Revision 8 of the certificate until January 31, 2023.

The References section has been updated to include the consolidated application.

**CONCLUSION**

Based on the statements and representations in the amendment request, the staff finds that these changes do not affect the ability of the packages to meet the requirements of Title 10 of the *Code of Federal Regulations* Part 71.
