Dear Mr. Heflin:

On December 12, 2017, members of the U.S. Nuclear Regulatory Commission (NRC) staff met with representatives of Wolf Creek Generating Station, Unit 1, to discuss an apparent violation related to the security related inspection finding documented in NRC Inspection Report 05000482/2017407 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML17306A559), issued on October 4, 2017. The focus of the regulatory conference was to discuss your views on this issue.

This meeting was closed to members of the public because security-related information was discussed. Copies of the NRC slides are included as Enclosure 1 to this letter. At the regulatory conference, your staff presented information that described your assessment of the finding and the corrective actions taken to resolve it, including a discussion of your root cause evaluation. A copy of your slides are included as Enclosure 2. The NRC used this information, in part, when assessing the final significance of the security-related inspection finding as documented in NRC Inspection Report 05000482/2017490 (ADAMS Accession No. ML17354A040), issued on December 20, 2017.

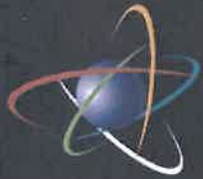
