Dear Mr. Sions:

Enclosed is Amendment No. 91 to your NRC Material License No. 24-00889-01 in accordance with your request dated September 22, 2017 (ML17270A318). Please note that we have updated and removed certain conditions in accordance with current NRC licensing policy.

In your September 22, 2017 letter, you confirmed that all residual licensed material located previously at the mobile van listed in Subitem No. 10.C. and at the 4321 Washington St., 4330 Wornall Rd., and 5844 NW Barry Rd. locations of use listed in Subitem No. 10.B. to the most recent amendment to your license had been removed – such that any remaining residual radioactivity in those locations of use is within the limits of Title 10 of the *Code of Federal Regulations* Part 20, Subpart E, and is ALARA.

Based on its review, the staff has concluded that all licensable radioactive material has been removed from the mobile van and the three locations of use referenced in your letter, and residual radioactive material attributable to licensed activities in the mobile van and those three locations of use does not exceed current NRC criteria. Based on these conclusions no further remediation or actions with respect to NRC regulated material in the locations of use referenced in your letter are required. The mobile van and the three locations authorized previously on your license, under Subitems 10.C. and 10.B. are suitable for unrestricted use.

Please review the enclosed license amendment document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9892 so that we may provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
