Desc: I'm seeking access to records under the Freedom of Information Act. I'd like to review the following:

(1) I've reviewed Accession Number ML15168A230 which is a NRC response to a letter LTR-15-0274 from a Richard Lenart to Congressman Peter J. Visclosky. Please provide ML15140A680 & LTR-15-274 (This could possibly be a typo in the Document Title in ADAMS and may actually be LTR-15-2741). Please redact all personal identifying information relating to Richard Lenart.

(2) Accession Number ML11109A149 is dated April 21, 2011 to former Senator Joseph I. Lieberman. This document refers to a March 25 letter written by Senator Lieberman. Please provide ML110980607 which NRC PDR informed me is Senator Lieberman's March 25th, 2011 letter so that I may review it. Also, I'd like to review the Package ML11109A146.

(3) ML12333A202 exists but most of the data is redacted. I would like to review the redacted information. Please review again and if the NRC can't fully display information provide reason as to why.
