1. Although Item 10.B. of your license authorizes storage and use at temporary jobsites, Item 7 of your response to my request for additional information dated March 17, 2017, stated that gauges will not be stored or used at temporary job sites without prior approval of the NRC.

Please confirm that you want to conduct operations at temporary jobsites (i.e., locations where work is conducted for limited periods of time).

If so, please commit to the statement: "temporary jobsites anywhere in the U.S. where the NRC maintains jurisdiction."

2. Please note that for Item 10.8 of your new license application dated March 7, 2017, you stated that non-routine maintenance will not be performed by Allied Testing and Inspection personnel.

Please submit either of the following:

- The statement: "The gauge manufacturer, or other person licensed by the NRC or an Agreement State will perform nonroutine maintenance or repair operations that require detaching the source or source rod from the gauge."

**OR**

- A request to perform this work "in-house", using the information in Appendix F of NUREG-1556, Vol. 1, Rev. 2 to support the request.
