Dear Mr. Wilkins:

On November 13, 2017, and November 15, 2017, an inspector from the U.S. Nuclear Regulatory Commission (NRC) conducted a routine inspection at your facility in Gaylord, Michigan, with continued in-office review through December 15, 2017. The purpose of the inspection was to review activities performed under your NRC license to ensure that activities were being performed in accordance with NRC requirements. The in-office review included a review of corrective actions to prevent recurrence of a violation of NRC regulatory requirements that were not available during the onsite inspection. Mr. Edward Harvey of my staff conducted a final exit meeting by telephone with you on December 18, 2017, to discuss the inspection findings.

During this inspection, the NRC staff examined activities conducted under your license related to public health and safety. Additionally, the staff examined your compliance with the Commission's rules and regulations as well as the conditions of your license. Within these areas, the inspection consisted of selected examination of procedures and representative records, observations of activities, and interviews with personnel.

Based on the results of this inspection, the NRC has determined that one Severity Level IV violation of NRC requirements occurred. The violation was evaluated in accordance with the NRC Enforcement Policy. The current Enforcement Policy is included on the NRC's website at <http://www.nrc.gov/about-nrc/regulatory/enforcement/enforce-pol.html>. The violation is of a security-related nature. Details of the violation are available in the enclosed, non-public Security Addendum (Enclosure 2). The violation is cited in the enclosed, non-public Notice of Violation (Notice) (Enclosure 1). The NRC is citing the violation in the enclosed Notice because the inspector identified it.
