Dear Mr. Rose:

Enclosed is Amendment No. 27 to your NRC Materials License No. 21-21068-01 in accordance with your request.

In your letter dated October 9, 2017, you requested that a location of use on your license be decommissioned and released. You provided a facility decommissioning report to support your request. The NRC staff has reviewed all of this information, including the final status surveys. Based on its review, the staff has concluded that all licensable radioactive material has been removed from the facility at 14920 23 Mile Road, Shelby Township, Michigan, and residual radioactive material attributable to licensed activities does not exceed current NRC criteria. Therefore, you may release 14920 23 Mile Road, Shelby Township, Michigan for unrestricted use.

Please note that your license is now in landscape format in accordance with NRC policy. Also, certain conditions of your license have been revised or removed to meet current NRC policy. Specifically, former Condition 14 regarding transportation was removed since this is now referenced in the preamble of your license (10 CFR Part 71). In addition, Condition 13 was revised to reflect a record retention requirement of three years, and Conditions 15 and 16 were revised to reflect updated language.


Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U. S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture.
