Further, Staff's response to Prehearing Question number 55 states that "...the discussion of environmental impacts in the draft Record of Decision is referring to cumulative impacts." This statement was made in error. Exhibit NRC-005 has therefore been updated to read as follows: "The discussion of environmental impacts in the draft Record of Decision on page 5 is referring to the potential impacts from constructing and operating the proposed Turkey Point Units 6 and 7. These construction and operational impacts, in the vicinity of the Turkey Point site, include the impacts as a result of preconstruction and NRC licensed activities."
