V) CONDITIONS:

GENERAL

1.1 This licence authorizes only the activity set out in section IV) unless amended by the Canadian Nuclear Safety Commission or a Designated Officer.

1.2 The licensee shall present this licence to a customs officer on importing controlled nuclear substances under this licence.

ANNUAL REPORT

2.1 The licensee shall, by January 31st of each year, submit to the Designated Officer a written annual report as per Appendix A on imports made under this licence during the previous calendar year. In the case of a licence expiry, a report should be submitted within 30 days of expiry on any imports made between the previous Annual Report and the licence expiry date. Nil reports should also be submitted if no imports were made during the year.
