Enclosed is Amendment No. 71 to your NRC Material License No. 24-08960-02 in accordance with your request.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

Please note the following, as it is a repeat of information I provided to you in my letter dated May 15, 2017. The only change made is the name and telephone number of the contact person regarding your fee billing invoice.

"I noticed that your license still authorizes depleted uranium in Subitem Nos. 6 – 9 F, although this license no longer authorizes an attenuation correction system.

It is possible that this authorization is resulting in an additional annual fee for this license. Please check your fee billing invoice or call Ms. Kelly Riner at 301-415-6246, if you are not sure.

If you are no longer in possession of this depleted uranium and if you want to have it deleted from the license, please contact me to discuss the types of information we will need to consider that request in a future amendment."

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you.

This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions.

Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
