This letter refers to your license amendment request dated December 20, 2017. Please find enclosed Amendment No. 7 authorizing an additional location of use.

Please note, in License Condition 14, letter dated April 27, 2016, requires that you store the Sr-90 source/device in its storage/shipping container, and that the storage location will be locked.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action(s) against you. This could include issuance of a Notice of Violation, or Imposition of a Civil Penalty, or an Order Suspending, Modifying or Revoking Your License as specified in the NRC Enforcement Policy. 
