BRIEF DESCRIPTION OF WORK ALTERNATE I

(a) The title of this project is: Purchase of Cisco Meeting Server Hardware, Software Licenses, and Installation Services

(b) Background: The NRC currently uses VTC in over 75 conference rooms located at headquarters and regional offices. All conference rooms are supported by a mix of Cisco hardware and software including Multipoint Conference Units (MCU), ISDN Gateways, and Secure IP Traversal Gateways. This equipment allows NRC to engage face to face with internal and external (domestic and international) stakeholders and forego the time and expense associated with traveling. The NRC recently learned that one component, the MCU, is no longer supported nor is capable of integrating with other, newly introduced technology the NRC is using, in this case Skype for Business (SFB). The purchase of the Cisco Meeting Server will allow the Agency to continue use of current investment in Cisco hardware, software and licenses while providing enhanced service by its ability to interface with SFB.

(c) Objective: The objective of this acquisition is to procure Cisco Meeting Server, hardware, software licenses, and installation services on a brand name only basis from an authorized NASA SEWP V Contractor that sells Cisco Meeting Server that is manufactured by Cisco Systems, Inc.
