
- Assume responsibility for implementing the Radiation Protection Program

  4. Verify implementation of corrective actions.

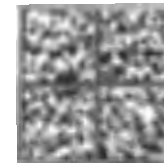
