As a follow-up to the voicemail I left you today, the U.S. Nuclear Regulatory Commission (NRC) is preparing to issue license amendments for the Oconee Nuclear Station, Units 1, 2, and 3. In accordance with Title 10 of the Code of Federal Regulations, Section 50.91(b), I am notifying you of the proposed issuance of these amendments.

Please reply if the State of South Carolina has comments on the following licensing action submitted to the NRC by Duke Energy Carolinas, LLC (the licensee): "Application to Revise Technical Specifications Regarding Control Room Envelope Habitability in Accordance with TSTF-448, Revision 3, using the Consolidated Line Item Improvement Process; License Amendment Request No. 2015-03," by letter ON-2017-028 dated March 30, 2017, as supplemented by letters ON 2017 039 and ONS-2017-067 dated May 11, and October 16, 2017 (Agencywide Documents Access and Management System (ADAMS) Accession Nos. ML17095A530, ML17139D352, and ML17292A051).

The proposed no significant hazards consideration for this amendment request was published in the Federal Register on July 18, 2017 (82 FR 32879).
