Please note that the format of the license has changed, as have some of the license conditions, due to an updating of our license generation database and revision during that change. That change includes the listing the authorized use with each material listed, which eliminates the problem that occurred in the previous license amendment,

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license.
