Dear Dr. Musson:

Enclosed is Amendment No. 33 to your NRC Material License No. 34-12736-02 in accordance with your November 24, 2017 letter (ML17332A101).

Also, as part of this review, we have noted that two program codes – 03122 for the spectrometer and 03123 for the gas chromatograph – both subject to fee category 3.P. – were inadvertently omitted from your license record due to an NRC oversight. These program codes have been added to your license record and may result in additional license fees.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.


