Wallace Fuhrman has been appointed Radiation Safety Officer for SSM Cardinal Glennon Children's Hospital and is responsible for ensuring the safe use of radiation. His responsibility is managing the radiation protection program; identifying radiation protection problems; initiating, recommending, or providing corrective actions; verifying implementation of corrective actions; stopping unsafe activities; and ensuring compliance with regulations. Mr. Fuhrman is hereby delegated the authority necessary to meet those responsibilities, including prohibiting the use of byproduct material by employees who do not meet the necessary requirements and shutting down operations, where justified, by the radiation safety office. He is required to notify management if staff do not cooperate and do not address radiation safety issues. In addition, he is free to raise issues with the Nuclear Regulatory Commission at any time. It is estimated that Mr. Fuhrman will spend an additional eight hours per week conducting radiation protection activities.

Wallace Fuhrman, BA, CNMT, RT(R,N), Radiation Safety Officer for SSM Health Cardinal Glennon Children's Hospital, has been properly trained through Sirtex to oversee Sir Spheres Y-90 selective internal radiation therapy (SIRT) under 35.1000.
