SUMMARY

Call placed to Keith Dupuis regarding an email request on November 6, 2017, from Carol Hill, Licensing Assistant, for the applicant to complete Appendix B NUREG 1556, Vol. 4, Rev. 1. The applicant replied on November 7, 2017, stating they were waiting for the fixed gauge vendor, Tracerco, to complete it for them. Mr. Dupuis informed me that they were pressing Tracerco to complete the appendix for them & then it would be reviewed by their Mr. Epperson, their Corporate RSO. I reviewed with Keith, simply what Appendix B was asking of the applicant and let him know that the basic information it requests is what the applicant can fundamentally supply. He mentioned that the Corporate RSO was very busy & traveling internationally and he was just trying to get the process going. We discussed that the appendix was needed to begin the basic review, along with the name of the appointed RSO, their credentials/training, commitments to NUREG 1556 Vol. 4, Rev. 1 radiation operating, safety & emergency procedure requirements, personnel monitoring, etc. We discussed the compressed time schedule for review of the new application & the license issuance deadline. He understood & requested my contact information so that the RSO appointee could call me & walk through the exact documents to be submitted with the application, to help expedite the new application review process. He said the RSO appointed will contact me within the next couple of days.


