Dear Ms. Dzanbazoff:

Enclosed is Amendment No. 55 to your Nuclear Regulatory Commission (NRC) Materials License No. 21-03298-05 in accordance with your request.

In correspondence dated October 23, 2017, you indicated that you wish to remove and release specified areas within the facility at 3901 Beaubien Blvd., Detroit, Michigan for unrestricted use.

The NRC staff has reviewed your final status surveys. Based on its review, the staff has concluded that all licensable radioactive material has been removed from the specified areas and residual radioactive material attributable to these licensed activities does not exceed current NRC criteria. Based on these conclusions no further remediation or actions with respect to NRC regulated material is required for this area of use and it is suitable for unrestricted use.



You will be periodically inspected by NRC. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture.
